Terms and conditions of the membership of D.S.T.V. Aloha, as agreed upon when entering membership of D.S.T.V. Aloha.

- Membership of the association is always supplemented with a membership of the Dutch triathlon federation (NTB), which is always a yearly membership.
- Contribution fees, license costs and other unpaid debts will be collected by debit after notice via email. Unpaid debts are e.g., participation costs of activities, among others. If you do not agree with the debit, you can arrange for its refund. Please contact your bank within eight weeks from the date on which your account was debited. Ask your bank for the conditions.
- The member declares to be familiar with the fact that performing service activities for the association is obligatory. This entails 2 bar shifts (per year) and helping 1 day at the UT-Triathlon organisation every year.
- The member will also purchase a UnionCard or CampusCard. In case the member does not acquire a UnionCard or CampusCard on time, any resulting penalties will be passed on to the member.
- The member gives the board of D.S.T.V. Aloha permission to publish photos of them on her website and other (social) media.
- The member gives the board of D.S.T.V. Aloha permission to send information emails to their e-mail address.
- The member is aware of the fact that abovementioned records can be used for administrative purposes by the board of D.S.T.V. Aloha until 2 years after termination of the membership.
- Termination of the membership ought to be communicated to the secretary and ought to be handed in at least 1 month prior to the ending date of the membership. No compensation for contribution payments will be made.
- The biannual (half-yearly) membership runs from September 1st to the 31th of January or from the February 1st to the 31th of August. A year membership runs from September 1st to the 31th of August.
- A member remains a member until the moment they, after termination, receive a confirmation of the board of D.S.T.V. Aloha. In case a member does not terminate the membership timely (before September 1st), they will automatically remain a member for the next association year.
